

Dear Patient,

Please follow the instructions below to transfer your medical images to your physician at Pacific Neuroscience Institute via Ambra Health.

Ambra Health recommends using Google Chrome. Chrome and Firefox do not require Java for upload. Ambra recommends the most recent versions of Adobe Flash and Java when using Internet Explorer. They can be downloaded at [adobe.com/flash](http://adobe.com/flash) and [java.com](http://java.com) respectively.

In order to upload your images, you will need access to the internet and a current web browser installed on your computer.

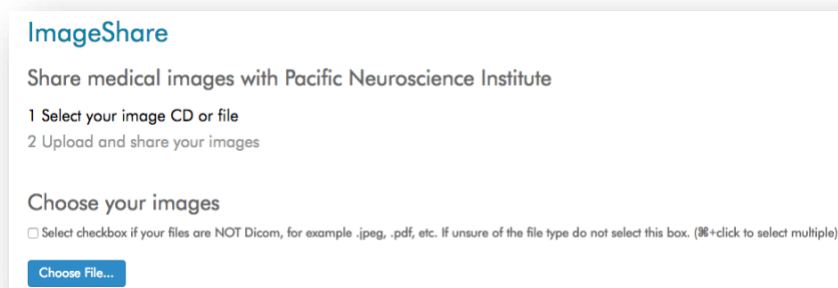
Please download the above software to your computer if using Internet Explorer. It should take only a few seconds.

**1. Navigate to the following site using the link below:**

You may be prompted to allow the application to run on your computer. Click to accept terms and hit run.

2. Insert your image disk or thumb-drive into your computer.
3. Click “Choose File” and then select the file(s) you wish to upload.



4. Once you've selected the file, click “Upload”.

The system will scan for DICOM objects on the file path you selected. This may take a few minutes. Once the scan is completed, you will be presented with your files for upload.

7. To upload any associated reports, click the “Choose File” button under the “Upload a Report” section.
